# "ABHIPSA FOUNDATION"

This supplementary trust deed of "ABHIPSA FOUNDATION" A Charitable Public Trust is executed on this 10th Day of March, 2022 by Mr. Kapil Jaiswal R/o 65A, Chander Vihar, Mandawali, Delhi - 110092 (hereinafter called the "Settler-cum- General Secretary") is in continuation of original trust deed duly registered on 4<sup>th</sup> January, 2016, at Registration Office SR VIIIA Preet Vihar, New Delhi/Delhi vide Serial No. 57, Deed No. 5 in Book No. 4, Volume No. 59 on pages on 32 - 51 for the year 2016-2017; which expression shall, unless excluded by or repugnant to the context, be deemed to include his executors, administrators and representatives of the one part and:

And whereas if any vacancy made in Board of trustees these vacancy can be fulfilled by co-operation.

And whereas the trustees have, at the request of the settler, agreed to act as the trustees of these presents as testified their being parties to and executing these presents.

And whereas it is necessary to declare the aims and objects of the public charitable public trust, being constituted under these presents.

Now this indenture witnesses as follows: -

1. That, in order to effectuate his aforesaid desire, the settler has set apart and handed over to the trustees, further a sum of Rs. 1,100 (Rupees One Thousand One Hundred Only) (hereinafter called the "Trust Fund" which expression shall include cash and any other property of investments of any kind whatsoever into which the same of any part thereof might be converted, invested or varied from time to time which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or



otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

2. **NAME:**

That the name of the trust shall now be "**ABHIPSA FOUNDATION**".

3. **OFFICEES:**

The registered office shall be situated at Office No. 101, First Floor, Lotus Tower, Vijay Block Laxmi Nagar, Near Nathu Sweets Delhi-110092 or places as the trustees may decide from time to time.

4. **AREA OF OPERTAION:**

Working areas of the trust will be all over India.

5. **OBJECTIVES:**

That the objects for which this trust is established are :-

- i. To provide relief measures among the affected people during the natural calamities, like flood, fire famine, draught, earthquake and cyclone and distribute free medicine food grains, cloths and provide rehabilitation center drinking water and other basic essential services.
- j. To work for the promotion and development of health awareness, sanitation women and child welfare population control, protection of environment and organize health education facilities among the urban and rural people weaker sections of society specially minorities death, SCs, STs etc. that they may lead a better quality of life and realize the essence of education/ freedom and reap the fruits of development.
- k. The society will work for the development of rural, urban, tribal and slum area poor, helpless, deprived, old age people, women, widows, handicapped people of all communities without caste, creed or sex for all round development in the filed of education, health improvement, sanitation, cultural development, socio economic problem and problem of unemployment among the society.

No members of the Trust shall have any personal claim on any movable or immovable properties of the Trust or make any profits, whatsoever, by virtue of trustee.
- yyy. To accept loan, Grant-in-aid, donation (Either in cash or kind), Subsidy or other assistance lawfully, either from National and/ or International agencies for the attainment of the objective of the trust.

6. All the activities shall be Non Profitable and shall be done on 'No Profit-No Loss' basis.
7. The Trust and the Trust funds shall be irrevocable for all the times.
8. All the incomes, earnings, movable/ immovable properties of the trust shall be solely utilized and applied towards the promotion of its Aims and Objects only as set forth in the deed of its Aims and objects only as set forth in the deed of the trust and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or the past members. No members of the trust shall have any personal claim on any movable or immovable properties of the trust or make any profits, whatsoever, by virtue of his membership.
9. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contribution from time to time.
10. That the Trust Fund shall not be applied for any purpose other than those specified in Para 3 herein above unless the other objects added to the trust objectives.
11. That the Trustees shall always maintain proper accounts of the Trust, which shall be kept at the office of the trust.
12. Subject to the Provisions of Income Tax Act, 1961 as amended from time, the Trustees will keep the Trust Fund or such portion thereof, as they may, in their absolute discretion, think fit and proper, without being answerable or accountable to the beneficiaries or any other party for any loss invested in such shares, stock, securities and debentures of acquisition or mortgage by way of fresh charge on any immovable property in India, of free-hold or lease-hold tenure, and may deposit the amounts with any scheduled Bank, as they think fit, in the matter of investment of Trust funds, the provisions of section 20 of the Indian Trust Act shall apply; in the event of Trustees purchasing any immovable property or properties or advancing moneys or mortgage, they shall be entitled to accept such title or evidence of title as they shall think fit in their absolute and uncontrolled discretion. The Trustees shall have power, if any deed it in their absolute discretion to sell the Trust Fund or any part thereof and any such immovable property purchased by them under the power aforesaid



and any other shares, securities, etc. and stand possessed of the money to arise from such sale upon after paying there out the expenses pertaining to such sale upon there out the expenses pertaining to such sale upon the Trusts and with the subject to powers and under these presents declared and contained concerning the Trust Fund which or the proceeds thereof, shall have laid out in purchase of property or properties as have laid out in purchase of property or properties as aforesaid or such of them as shall be then subsisting and capable of taking effect.

13. That for the furtherance of the objects of the trust, the trustees shall have the following powers:

- a. To accept any donation, contribution, loan, grant or subscription in cash or in kind, from any person (s) or association of person (s) or body corporate or trust, with or without conditions.
- b. To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- c. To open account in the name of the Trust, with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- d. To adjust, settle, compromise, compound refers to arbitration, all actions, Suits claims, demands and proceedings regarding the Trust Fund.
- e. To Engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator of Settler or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.
- f. To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust Fund or part thereof for any of the objects of the Trust.
- g. To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- h. To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for the corpus of the Trust Fund or part thereof for any of the objects of the Trust.





- i. To join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.
- j. To give aid by way of donations out of the income or the corpus of the Trust fund or otherwise, to different charitable institutions, may have been established or which may hereinafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, organization or Trustees to start maintain, or carry out such charitable objects.
- k. The fund of the trust shall be kept invested in accordance with the provisions of section 11(5) of the Income Tax Act, 1961.
- l. To settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- m. To borrow money either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustee to make such borrowing on payment of such interest and otherwise on such term and conditions as they may in their absolute discretion think fit.
- n. To apply to the Government, public bodies, urban, local municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance including lease and substance of property with a view to promote the objects of the Trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to put to any proper condition upon which such grants and other payments including taking land on lease may be made.
- o. To take over or amalgamate with any other Charitable Public Trust, Trust, association, or institution with similar objects.
- p. To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.



- q. To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
- r. To take land/property on lease and then after sublease the land/property to the farmers and other organizations like co-operative/society/urban public bodies/gram panchayat or any being thereof in rural area/ local municipal/ district and other bodies corporation/ company for farming/ agriculture/ plantation purposes.
14. The Trustees shall be accountable only for such money, and funds, which will actually come into their hands.
15. The Trustees will not be entitled to receive any remuneration, but the Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
16. The Managing Trustee for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period of on such terms as to retirement and reappointment as the trustees for the time being consider proper.
17. A person shall cease to be a Trustee either:
- If he/she without leave of absence does not attend three consecutive meeting of the Trustees or for one calendar year, whichever is longer, or for one calendar year, whichever is longer, or
  - If he/she is requested to resign by 2/3rd or as near thereto as possible of the remaining trustees.
18. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so. The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:
- a) 2/3<sup>rd</sup> Trustees shall form a quorum for a meeting of the Trustees.
  - b) All matters will be decided mutually by the Trustee.
  - c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.
19. The Trustees shall have the power to determine in case of doubt whether any money of property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained



shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.

20. Two-thirds majority shall constitute the office of the Trust at Delhi unless changed by the Trustees.

#### POWER & FUNCTION OF THE OFFICE BEARER:

##### PRESIDENT:

President shall be the subject to control and supervision of governing body, have the power to make general directions and management of the affairs relating to the trust.

The President of the Trust shall also enjoy the following powers and duties:

- President shall summon and preside over all the meetings of trust.
- President shall have power to call any emergent meeting by short notice.
- President shall have the power to allow inclusion of any subject/matter in the agenda for the discussion in the course of proceeding/meeting.
- At the time of voting on any matter/subject (except election), if the total votes of the groups of members happen to be equal in number, the President has the power to cast an extra vote to decide the matter/subject.
- In the course of any proceeding or meeting of the trust, the decision of the President shall be considered as final (in case of dispute as to the meaning or interpretation or any rule).
- In case it is necessary to decide any point/matter/issue urgently and there is no time to call the board of trustee meeting, the President have the power to decide the point/issue/matter, but he/she shall bring the matter to the notice of the body of trustee as early as it is possible.
- In the event of any office bearer(s) seat falling vacant, the powers and functions of that office bearer/executive member would vest in the President.

##### VICE-PRESIDENT:

- In the absence of the President, Vice-President shall enjoy all the powers and duties which are entrusted to the President. He/She will assist the President in his/her day to day functioning from time to time.

##### GENERAL SECRETARY:

Unless or until General Secretary has been elected or otherwise relolved in the meeting, the power and function of the present shall be in the hands of settlor-cum- president of the trust.

- a. Secretary will summon and attend the meeting of the trust.
- b. Secretary will prepare the Membership Register as well as the proceeding register to record the minutes of the proceedings of the trust meetings and have them duly signed by the trustees/members who attend the meetings.

- c. Secretary will sign all the papers/letters, on behalf of the trust, to conduct its correspondences.
- d. To appoint/terminate such staff as may be required for effective & efficient management of the affairs of the trust, and fix their remuneration.
- e. Secretary will get the accounts of the trust audited by the qualified auditor, appointed by the governing body of the society.
- f. It shall be his duty to see that the resolution at the respective meeting are implemented and give to effect to timely.
- g. He shall be at liberty to spend for the purpose of the trust without sanction of the Board of Trustee to do all such other lawful notes, deeds of things as incidental or conducive to the attachment of the trust.
- h. He shall produce the accounts of the trust before Board of Trustee for approval.
- i. He shall appoint, suspend, discharge, fix the salary, make payment of the employees of the Institution and conducted by the trust on the behalf of the Board of Trustee.
- j. He shall maintain the account in proper and prescribed form. He shall deposit and withdraw the amount of the trust in the bank or in the post office.
- k. He will produce the expenditure of the trust before the board of trustee for approval.

**TREASURER:**

Unless or untill treasurer has been elected or otherwise reloed in the meeting, the power and function of the present shall be in the hands of settlor-cum- president of the trust.

- a. All the funds of trust shall remain under the care and management of treasurer of the trust.
- b. He/She shall maintain the accounts of all money, which is received and/or paid by him/her on behalf of the trust.
- c. He/She shall produce all the accounts-book in every board of trustee.
- d. All the cash excess of the above amount (or the amount fixed by the board of trustee) shall be deposited in any nationalized bank/banks, selected by the board of trustee.

**21. MAINTENANCE OF BOOKS OF ACCOUNTS:-**

Regular books of accounts of the Trust shall be maintained incorporating all the revenue and expenditure and such books shall be closed once every 31st March. The same shall be got audited by a Chartarted Accountant appointed or reappointed every year and the necessary returns shall be filed with the authorities.

- 22. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose, which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.



23. BANK OPERATION:

The bank accounts of the Trust and/or institution run/conducted by the Trust will be operated by the compulsory signatures of the Settlor-cum-president singly or jointly with the Trustee or his/her given instructions for opening and operation of such account (s) by one or more of the Trustees or by an agent appointed by the Managing Trustee. Each and every bank account will be opened and closed with the final approval/consent of Managing Trustee. Also, the bank account(s) will remain in force until notice in writing of its withdrawal or cancellation is given to the bank by the Managing Trustee of the trust.

24. APPLICATION OF INCOME AND FUND:

The Board of Trustees shall be empowered to invest the funds of the Trust in movable or immovable properties, in such manner as they deem fit for the purpose of the objects of the trust provided that such investments shall be in accordance with the provision of Section 13(1) read with Section 11(5) of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to charitable trusts.

25. DISSOLUTION OF TRUST:

In the event of dissolution of the trust, the entire trust funds, existed as on the date of such dissolution, shall be realized and first be used for the payment of liabilities of the trust. The assets left if any, shall be disbursed, after obtaining prior approval of the Commissioner of Income Tax (Exemption), to other Trust having similar objectives and who have been granted registration u/s 12AA / 12AB of the Income Tax Act, 1961."

In no circumstances, such left assets, shall be distributed in any manner, to any member of the governing body or their relatives or related concerns:

26. LEGAL JURISDICTION:

The cases pertaining to the Trust shall be filed and tried in the court/s in Delhi only.

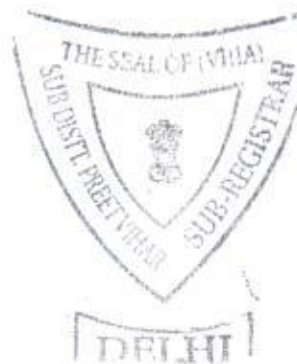
